## RECYCLING

Empty all recyclables loosely into the blue Recycling containers. Place shredded paper in a paper bag.



### ORGANICS

Place food scraps, uncoated food-soiled paper/ cardboard, and yard waste in the green Organics container. No glass and plastics (including bioplastics).

## LANDFILL

Put non-recyclable, non-compostable,

non-toxic items in the gray Landfill cart.

#### **ADDITIONAL SERVICES**

#### **NEED A KITCHEN PAIL?**

Contact your property manager to arrange for a free pail from Recology.



This reusable kitchen pail helps you collect food scraps from your home and transport them to your centralized green organics container. (No plastic bags allowed.)

- Use paper bags, scrap mail, or paper towels to line the kitchen pail.
- Empty kitchen pail every other day.
- Wash pail with warm water and soap.
- Dry pail and reuse.

#### BULKY ITEM COLLECTION

**One free** Bulky Item Collection (BIC) is provided per calendar year to each multifamily complex. The maximum allowed per unit is .5 cubic yards.

Property managers must coordinate with Recology Vallejo to schedule the one free BIC for the entire complex.

#### **BIC Guidelines:**

Accepted: Mattresses, furniture, household appliances such as refrigerators, freezers, washers, dryers, and electronics such as computers, monitors, and TVs.

**Note:** Electronics and appliances must be kept separate from other items. **Unaccepted:** Hazardous waste, dirt, rock, concrete, and commercial-sized appliances.

#### HOUSEHOLD HAZARDOUS WASTE

#### Battery, Oil, Paint, and Antifreeze (BOPA) Facility

2021 Broadway St., Vallejo 94589 Open 8 AM – 3:30 PM, Thursday – Saturday

Residents can dispose of unwanted light bulbs, oil, paint, household and automotive batteries, and antifreeze for free.

BOPA also accepts limited amounts of electronic waste, books, cardboard, sharps, and mattresses.

Dispose of all other hazardous materials at the Household Hazardous Waste Facility, 889 A Devlin Road, American Canyon, 94503. For hours and details, call 1.800.984.9661.



#### MOVING OUT?

If you are moving and cannot wait for the standard BIC at your complex, consider these options:

- Check local social media groups and drop-off locations like Eco Thrift Vallejo and Valcore community recycling.
- Take items to the Devlin Transfer Station, 889 Devlin Road, American Canyon 94503. Fees apply.
- Bring cardboard, electronics, and mattresses to our Battery, Oil, Paint, Antifreeze (BOPA) facility, 2021 Broadway St., Vallejo. No charge.

#### HOLIDAY SCHEDULE

There are no collection services on Thanksgiving Day, Christmas Day, or New Year's Day. Collection will occur on the next regular business day following the holiday.

#### HOLIDAY TREES

Trees must be cut into sections no greater than 3 feet long and placed inside the green organics cart with the lid closed. This is **free** and part of your regular service.

All lights, ornaments, tinsel, and garland must be removed. No flocked trees. Flocked trees go in the garbage bin.





#### **RECOLOGY COMPLIANCE SOLUTIONS**

Each multifamily complex has unique locations for their Recycling, Organics, and Landfill carts. Contact your property manager for specific container locations.









#### PLEASE REMEMBER

No plastic packaging, empty all recyclables loosely into the blue recycling container.

#### WHAT IF MY COMPLEX DOESN'T HAVE A COMPOST PROGRAM?

Ask your property manager to contact Recology and set up organics service.

## BAG YOUR LANDFILL ITEMS & KEEP CONTAINER LIDS CLOSED!

This helps prevent birds and other animals from getting into your container and littering the street.

#### WASTE ZERO SERVICES

Recology Waste Zero team members work with property managers to help their multifamily complexes meet state mandated program requirements.

- AB 341 Mandatory Commercial Recycling: Multifamily residential dwellings of five or more units must subscribe to recycling service. Tenants are required to discard recyclable materials in designated bins.
- SB 1383 Mandatory Organics Waste Collection: All commercial, multifamily, and residential customers are required to divert organic materials from the landfill. The law also requires the state to increase edible food recovery by 20% by 2025.

We provide a single point of contact to help property managers implement new recycling and organic programs, improve existing ones, and access resources.
